- 第一條 本作業規定依大學法及教育部發布之學生逕修讀博士學位辦法訂定之。
- Article 1 This Regulations has been established pursuant to the University Act and the Regulations on Direct Admission of Students to PhD Programs promulgated by the Ministry of Education.
- 第二條 各教學單位每學年逕修讀博士學位名額,以該教學單位當學年度教育部核定博士班招生 名額百分之四十為限,並得於學院內流用。但各教學單位之核定招生名額不得全數以逕 修讀博士學位方式錄取,但有下列情形之一者,不在此限:
 - 一、教學單位之核定博士班招生名額為一人。
 - 二、經教育部核定之人才培育計畫或專案。

核准跨校逕修讀博士學位之名額,以教育部核定博士班招生名額百分之五為上限。

以中央研究院與本校合作辦理國際研究生學程(以下簡稱TIGP)管道入學之碩士班學生,

辦理逕修讀TIGP博士班學程時,其名額不受本作業規定限制。

逕修讀博士學位名額應包含於當學年度教育部核定學校招生總量內。

Article 2 The number of students directly admitted by each academic unit to the PhD program for each academic year shall not exceed 40% of the number of students approved by the Ministry of Education for admission to the PhD program of the academic unit in that academic year. Such numbers may be transferred between units in a college. Students admitted to each academic unit as approved shall not be all via direct admission to the PhD program.

However, this does not apply to the following circumstances:

- 1. The enrollment quota for the doctoral program approved by the academic unit is one student.
- 2. Talent cultivation plans or projects approved by the Ministry of Education.

The number of students approved for cross-university direct admission to the PhD program shall not exceed 5% of the number of students approved by the Ministry of Education for admission to the PhD program.

Students enrolled in a master's program through the Taiwan International Graduate Program (hereinafter referred to as TIGP), a cooperative initiative between the Academia Sinica and NYCU, are not limited by this operation direction when applying for a TIGP doctoral program. The number of students directly admitted to the PhD program shall be included in the total number of students approved by the Ministry of Education for admission to NYCU in each academic year.

- 第三條 學生符合下列資格之一,並經原就讀或相關教學單位助理教授以上二人推薦,得申請逕修 讀博士學位:
 - 一、修讀學士學位應屆畢業生,修業期間成績優異,並具有研究潛力。
 - 二、修讀碩士學位學生,修業期間成績優異,並具有研究潛力。

前項所稱成績優異或具研究潛力之審查標準及繳交資料,應由各教學單位相關會議訂定。台灣聯合大學系統他校學生申請跨校逕修讀博士學位,除應符合前二項規定外,並依「台灣聯合大學系統學生逕修讀博士學位作業要點」及本作業規定辦理。

- Article 3 Any student fulfilling any of the following requirements and who has been recommended by at least two professors at assistant or higher level from the original academic unit the student is enrolled in or a relevant academic unit may apply for direct admission to the PhD program:
 - (1) Any current bachelor's graduate with outstanding performance during his/her study period and who possesses potential for research.
 - (2) Any master's student with outstanding performance during his/her study period and who possesses potential for research.

The criteria and the information to be submitted for review of whether any student has outstanding performance or possesses potential for research under the preceding paragraph shall be determined by a relevant meeting of each academic unit.

Students of any other university under the University System of Taiwan who apply for cross-university direct admission to the PhD program shall fulfill the requirements in the preceding two paragraphs and shall be in accordance with the "University System of Taiwan (UST) Guidelines for Accelerated Doctoral Program" and this Regulations.

- 第四條 申請逕修讀博士學位之學生,第一梯次應於七月十五日前;第二梯次應於一月十日前,向 擬就讀之教學單位繳交規定之文件。各教學單位於接受申請後,應依據前條所訂標準審 查,其方式由各教學單位訂定。
- Article 4 Any student applying for direct admission to the PhD program shall submit the required documents to the academic unit in which he/she intends to enroll by July 15 for the first phase or by January 10 for the second phase. Each academic unit which has accepted any such application shall review it in accordance with the criteria established under the preceding article. The method of review shall be determined by each academic unit.
- 第五條 申請逕修讀博士學位之學生,第一梯次應於八月十五日前;第二梯次應於一月三十一日前,經擬就讀之各教學單位審查確認符合規定,並提經相關會議通過者,送各學院相關會議複審完畢,由受理申請之教學單位檢具相關會議紀錄,申請學生名冊暨相關之文件簽陳教務長核定後,申請之學生始得逕修讀博士學位。
- Article 5 For any student applying for direct admission to the PhD program, his/her application shall be reviewed by the academic unit in which he/she intends to enroll as having met the requirements, approved by a relevant meeting, and submitted to a relevant college-level meeting for a second review by August 15 for the first phase or by January 31 for the second phase. The applying student may be directly admitted to the PhD program only after the academic unit accepting his/her application has submitted the relevant meeting minutes, a list of applying students and the relevant documents to the Dean of Academic Affairs for approval.
- 第六條 核准逕修讀博士學位學生,為本校博士班一年級錄取生。入學後之修業規定,悉依各教學 單位規章辦理。

核准逕修讀博士學位學生,不得申請保留學籍。

核准逕修讀博士學位之碩士生,非經申請撤銷逕修資格,不得再參加碩士班學位考試。 核准逕修讀博士學位之學士班應屆畢業生,在就讀前需取得學士學位。在就讀前未取得學 士學位者,取消其逕修讀博士學位資格。

Article 6 Any student approved for direct admission to the PhD program shall be admitted as a first-year PhD student of NYCU. Requirements for study after admission shall be subject to the regulations of each academic unit

Any student approved for direct admission to the PhD program shall not apply to retain his/her student status.

Any master's student approved for direct admission to the PhD program who has not applied for revocation of his/her eligibility for direct admission may not participate again in any master's degree examination.

Any current bachelor's graduate approved for direct admission to the PhD program shall acquire a bachelor's degree prior to his/her admission. If the graduate fails to acquire a bachelor's degree prior to his/her admission, his/her eligibility for direct admission to the PhD program shall be

canceled.

- 第七條 逕修讀博士學位學生,有下列情形之一者,<mark>欲轉回原碩士班或轉入相關領域碩士班</mark>得於每 學期結束前檢具申請表,經修讀博士班同意<u>後</u>,由該碩士班召開會議審查通過並簽請教務 長核定,得轉回(入)該碩士班:
 - 一、因故中止修讀博士學位。
 - 二、未通過博士候選人資格考核。
 - 三、未通過博士學位考試且未符合本條第二項規定。

前項逕行修讀博士學位研究生修業期滿,修得就讀教學單位博士班規定之學分數及該教學單位規定之各項考核規定,但未通過博士學位考試,其所提論文若經博士學位考試委員會決定為合於碩士學位標準者,得授予碩士學位。

- Article 7 If any of the following circumstances applies to any student directly admitted to the PhD program, he/she may submit an application before the end of each semester to resume to the original master's program or transfer to a related field master's program. After the application has been approved by the department of the PhD program in which he/she is enrolled, the master's program will convene a meeting to review and approve the application, and approved by the Dean of Academic Affairs, he/she may resume or transfer to the master's program.:
 - (1) The student has ceased his/her study in the PhD program, regardless of the reason.
 - (2) The student has failed to pass the PhD candidate qualifying examination.
 - (3) The student has failed to pass the PhD degree examination, but passed the PhD candidate qualifying examination.

Where any graduate student directly admitted to the PhD program under the preceding paragraph whose study period has expired has earned the credits required by the PhD program of the academic unit in which he/she is enrolled and passed other examinations required by the academic unit but has failed to pass the PhD degree examination, he/she may be granted a master's degree if the thesis he/she has submitted is determined by the PhD degree examination committee to be fulfilling the requirements for a master's degree.

第八條 逕行修讀博士學位學生經核准轉入碩士班就讀者,其身份改變事實,應由教務處知會生活 輔導組。

轉回或轉入碩士班後,不得再行申請逕行修讀博士學位。

Article 8 The Office of Academic Affairs shall inform the Division of Life Guidance Services regarding the change of identity of the status of students for the Direct Pursuit of PhD Degree who are approved to be transferred to the Master's program.

The students who resume or transfer to the Master's program from the PhD program may not apply for the Direct Pursuit of PhD Degree again.

- 第九條 學生經原教學單位或相關教學單位會議審查通過,並依規定修讀完成碩士學位應修課程, 提出論文,經碩士學位考試委員會考試通過者,授予碩士學位,其修讀博士學位修業期間 及休學紀錄均不併入修讀碩士學位最高修業年限核計。
- Article 9 Any student who has been reviewed and approved by a meeting of the original or a relevant academic unit, completed the courses required for a master's degree, submitted a thesis and passed the examination conducted by the master's degree examination committee shall be granted a master's degree. The study period and records of leave of absence of the student in the PhD program will not be included in the calculation of his/her maximum study period in the master's program.
- 第十條 同時獲准本校或台灣聯合大學系統二個以上逕行修讀博士學位資格者,應擇一就讀或辦 理雙重學籍。
- Article 10 Those who have obtained two or more doctoral degree qualifications from NYCU or The University System of Taiwan should either enroll in one of them, or apply for dual student status.
- 第十一條 本作業規定經教務會議通過後實施,修正時亦同。

Article 11 This Regulations and any amendment thereto shall be implemented after being approved by an academic affairs meeting.
